The latest news as of 6pm on Tuesday 12 January

46 deaths and 3,086 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 46 additional deaths among people with COVID-19 in Ireland. 2 of these deaths occurred in December 2020, and the remaining 44 occurred in January 2021
- there have been 2,397 COVID-19 related deaths in Ireland
- 3,086 additional cases of COVID-19 have been confirmed
- there have now been 155,591 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 1,692 COVID-19 patients are hospitalised, of which 158 are in ICU. There have been 128 additional hospitalisations in the past 24 hours
