The latest news as of 5.45pm on Wednesday 13 January

63 deaths and 3,569 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 63 additional deaths among people with COVID-19 in Ireland. 5 of these deaths occurred in November 2020, 1 of these deaths occurred in December 2020, and the remaining 56 occurred in January 2021. The date of death for one reported death remains under investigation
- there have been 2,460 COVID-19 related deaths in Ireland
- 3,569 additional cases of COVID-19 have been confirmed
- there have now been 159,144 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 1,770 COVID-19 patients are hospitalised, of which 172 are in ICU. There have been 133 additional hospitalisations in the past 24 hours
