The latest news as of 6pm on Monday 18 January

8 deaths and 2.121 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 8 additional deaths among people with COVID-19 in Ireland. All 8 of these deaths occurred in January
- there have been 2,616 COVID-19 related deaths in Ireland
- 2,121 additional cases of COVID-19 have been confirmed
- there have now been 174,843 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 1,975 COVID-19 patients are hospitalised, of which 200 are in ICU. There have been 102 additional hospitalisations in the past 24 hours
