The latest news as of 5.45pm on Wednesday 20 January

61 deaths and 2,488 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 61 additional deaths among people with COVID-19 in Ireland. Of the deaths reported today, 58 deaths occurred in January. There are 3 deaths where the date of death is under investigation
- there have been 2,768 COVID-19 related deaths in Ireland
- 2,488 additional cases of COVID-19 have been confirmed
- there have now been 179,324 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 1,923 COVID-19 patients are hospitalised, of which 210 were in ICU at 11am. There have been 85 additional hospitalisations in the past 24 hours
