## The latest news as of 6pm on Thursday 21 January

51 deaths and 2,608 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 51 additional deaths among people with COVID-19 in Ireland. 49 of these deaths occurred in January
- there have been 2,818 COVID-19 related deaths in Ireland
- 2,608 additional cases of COVID-19 have been confirmed
- there have now been 181,922 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 1,943 COVID-19 patients are hospitalised, of which 214 are in ICU. There have been 105 additional hospitalisations in the past 24 hours
