The latest news as of 6.15pm on Friday 22 January

52 deaths and 2,371 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 52 additional deaths among people with COVID-19 in Ireland. 50 of these deaths occurred in January, and there are 2 deaths where the date of death is under investigation
- there have been 2,870 COVID-19 related deaths in Ireland
- 2,371 additional cases of COVID-19 have been confirmed
- there have now been 184,279 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 1,931 COVID-19 patients are hospitalised, of which 219 are in ICU. There have been 78 additional hospitalisations in the past 24 hours
