The latest news as of 5.45pm on Saturday 23 January

77 deaths and 1,910 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of additional deaths among people with COVID-19 in Ireland. 76 of these deaths occurred in January, and there 1 death took place in December 2020.
- there have been 2,947 COVID-19 related deaths in Ireland
- 1,910 additional cases of COVID-19 have been confirmed
- there have now been 186,184 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 1,892 COVID-19 patients are hospitalised, of which 217 are in ICU. 59 additional hospitalisations in the past 24 hours.
