## The latest news as of 5.45pm on Sunday 24 January

23 deaths and 1,378 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 23 additional deaths among people with COVID-19 in Ireland. All 23 of these deaths occurred in January
- there have been 2,970 COVID-19 related deaths in Ireland
- 1,378 additional cases of COVID-19 have been confirmed
- there have now been 187,554 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 1,931 COVID-19 patients are hospitalised, of which 218 are in ICU. There have been 44 additional hospitalisations in the past 24 hours
