The latest news as of 6.45pm on Monday 25 January

7 deaths and 1,372 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 7 additional deaths among people with COVID-19 in Ireland. All of these deaths occurred in January
- there have been 2,977 COVID-19 related deaths in Ireland
- 1,372 additional cases of COVID-19 have been confirmed
- there have now been 188,923 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 1,905 COVID-19 patients are hospitalised, of which 219 are in ICU. There have been 58 additional hospitalisations in the past 24 hours
