The latest news as of 6.30pm on Tuesday 26 January

90 deaths and 928 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 90 additional deaths among people with COVID-19 in Ireland. 89 of these deaths occurred in January, and there is one death where the date of death is under investigation
- there have been 3,066 COVID-19 related deaths in Ireland
- 928 additional cases of COVID-19 have been confirmed
- there have now been 189,851 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 1,750 COVID-19 patients are hospitalised, of which 216 are in ICU. There have been 65 additional hospitalisations in the past 24 hours
