The latest news as of 6.30pm on Wednesday 27 January

54 deaths and 1,335 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 54 additional deaths among people with COVID-19 in Ireland. 50 of these deaths occurred in January
- there have been 3,120 COVID-19 related deaths in Ireland
- 1,335 additional cases of COVID-19 have been confirmed
- there have now been 191,182 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 1,670 COVID-19 patients are hospitalised, of which 217 are in ICU. There have been 81 additional hospitalisations in the past 24 hours
