## The latest news as of 6.15pm on Thursday 28 January

47 deaths and 1,466 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 47 additional deaths among people with COVID-19 in Ireland. 46 of these deaths occurred in January
- there have been 3,167 COVID-19 related deaths in Ireland
- 1,466 additional cases of COVID-19 have been confirmed
- there have now been 192,645 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 1,567 COVID-19 patients are hospitalised, of which 216 are in ICU. There have been 69 additional hospitalisations in the past 24 hours
