The latest news as of 6pm on Friday 29 January

48 deaths and 1,254 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 48 additional deaths among people with COVID-19 in Ireland. 45 of these deaths occurred in January
- there have been 3,214 COVID-19 related deaths in Ireland
- 1,254 additional cases of COVID-19 have been confirmed
- there have now been 193,892 confirmed cases of COVID-19 in Ireland
- as of 2pm today, 1,518 COVID-19 patients are hospitalised, of which 211 are in ICU. 51 additional hospitalisations in the past 24 hours.
