The latest news as of 6pm on Saturday 30 January

79 deaths and 1,414 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 79 additional deaths among people with COVID-19 in Ireland. 78 of these deaths occurred in January
- there have been 3,292 COVID-19 related deaths in Ireland
- 1,414 additional cases of COVID-19 have been confirmed
- there have now been 195,303 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Saturday), 1,492 COVID-19 patients are hospitalised, of which 211 are in ICU. There have been 55 additional hospitalisations in the past 24 hours
