## The latest news as of 5.30pm on Sunday 31 January

15 deaths and 1,247 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 15 additional deaths among people with COVID-19 in Ireland. All 15 deaths occurred in January
- there have been 3,307 COVID-19 related deaths in Ireland
- 1,247 additional cases of COVID-19 have been confirmed
- there have now been 196,547 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Sunday), 1,516 COVID-19 patients are hospitalised, of which 211 are in ICU. There have been 39 additional hospitalisations in the past 24 hours
