The latest news as of 6pm on Monday 1 February

10 deaths and 1,062 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 10 additional deaths among people with COVID-19 in Ireland. All 10 deaths occurred in January
- there have been 3,317 COVID-19 related deaths in Ireland
- 1,062 additional cases of COVID-19 have been confirmed
- there have now been 197,553 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Monday), 1,436 COVID-19 patients are hospitalised, of which 207 are in ICU. There have been 38 additional hospitalisations in the past 24 hours
