The latest news as of 6pm on Tuesday 2 February

101 deaths and 879 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 101 additional deaths among people with COVID-19 in Ireland. 83 of these deaths occurred in January and 18 occurred in February
- there have been 3,418 COVID-19 related deaths in Ireland
- 879 additional cases of COVID-19 have been confirmed
- there have now been 198,424 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Tuesday), 1,388 COVID-19 patients are hospitalised, of which 207 are in ICU. There have been 45 additional hospitalisations in the past 24 hours
