The latest news as of 6pm on Wednesday 3 February

94 deaths and 1,013 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 94 additional deaths among people with COVID-19 in Ireland. 47 of these deaths occurred in February, 44 occurred in January, 2 in December and 1 in November
- there have been 3,512 COVID-19 related deaths in Ireland
- 1,013 additional cases of COVID-19 have been confirmed
- there have now been 199,430 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Wednesday), 1,334 COVID-19 patients are hospitalised, of which 203 are in ICU. There have been 66 additional hospitalisations in the past 24 hours
