## The latest news as of 6.15pm on Thursday 4 February

75 deaths and 1,318 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 75 additional deaths among people with COVID-19 in Ireland. 46 of these deaths occurred in February, 27 occurred in January, and 2 earlier
- there have been 3,586 COVID-19 related deaths in Ireland
- 1,318 additional cases of COVID-19 have been confirmed
- there have now been 200,744 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Thursday), 1,284 COVID-19 patients are hospitalised, of which 188 are in ICU. There have been 74 additional hospitalisations in the past 24 hours
