The latest news as of 5.45pm on Friday 5 February

35 deaths and 1,047 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 35 additional deaths among people with COVID-19 in Ireland. 29 of these deaths occurred in February and 6 occurred in January
- there have been 3,621 COVID-19 related deaths in Ireland
- 1,047 additional cases of COVID-19 have been confirmed
- there have now been 201,763 confirmed cases of COVID-19 in Ireland
- as of 2pm today (Friday), 1,221 COVID-19 patients are hospitalised, of which 181 are in ICU. There have been 51 additional hospitalisations in the past 24 hours
