The latest news as of 6pm on Tuesday 9 February

68 deaths and 556 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 68 additional deaths among people with COVID-19 in Ireland. 50 of these deaths occurred in February, 15 occurred in January and 2 in December. There is 1 death where the date of death is under investigation
- there have been 3,752 COVID-19 related deaths in Ireland
- 556 additional cases of COVID-19 have been confirmed
- there have now been 204,940 confirmed cases of COVID-19 in Ireland
- as of 8am today (Tuesday), 1,104 COVID-19 patients are hospitalised, of which 182 are in ICU. There have been 54 additional hospitalisations in the past 24 hours

As of 6 February, there have been 236,996 doses of COVID-19 vaccine administered in Ireland:

- 152,652 people have received their first dose
- 84,344 people have received their second dose
