The latest news as of 5.45pm on Wednesday 10 February

54 deaths and 1,006 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 54 additional deaths among people with COVID-19 in Ireland. 45 of these deaths occurred in February, 5 occurred in January and 4 are still under investigation
- there have been 3,794 COVID-19 related deaths in Ireland
- 1,006 additional cases of COVID-19 have been confirmed
- there have now been 205,939 confirmed cases of COVID-19 in Ireland
- as of 8am today (Wednesday), 1,032 COVID-19 patients are hospitalised, of which 173 are in ICU. There have been 40 additional hospitalisations in the past 24 hours

As of 8 February, there have been 243,353 doses of COVID-19 vaccine administered in Ireland:

- 154,900 people have received their first dose
- 88,453 people have received their second dose
