The latest news as of 6pm on Friday 12 February

23 deaths and 921 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 23 additional deaths among people with COVID-19 in Ireland. 21 of these deaths occurred in February and two occurred in January
- there have been 3,865 COVID-19 related deaths in Ireland
- 921 additional cases of COVID-19 have been confirmed
- there have now been 207,720 confirmed cases of COVID-19 in Ireland
- as of 8am today (Friday), 959 COVID-19 patients are hospitalised, of which 173 are in ICU. There have been 53 additional hospitalisations in the past 24 hours

As of 9 February, there have been 248,284 doses of COVID-19 vaccine administered in Ireland:

- 158,904 people have received their first dose
- 89,380 people have received their second dose
