## The latest news as of 5.30pm on Saturday 13 February

#### 66 deaths and 1,078 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 66 additional deaths among people with COVID-19 in Ireland. 41 of these deaths occurred in February, 8 in January, 7 in December and 9 in November (1 date is still being investigated)
- there have been 3.931 COVID-19 related deaths in Ireland
- 1,078 additional cases of COVID-19 have been confirmed
- there have now been 208.796 confirmed cases of COVID-19 in Ireland
- as of 8am today (Saturday), 898 COVID-19 patients are hospitalised, of which 171 are in ICU. There have been 44 additional hospitalisations in the past 24 hours

As of Thursday 11 February, there have been 261,073 doses of COVID-19 vaccine administered in Ireland:

- 171,239 people have received their first dose
- 89,834 people have received their second dose
