## The latest news as of 6pm on Monday 15 February

### 821 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been informed of any additional deaths among people with COVID-19 in Ireland
- there have been 3,948 COVID-19 related deaths in Ireland
- 821 additional cases of COVID-19 have been confirmed
- there have now been 210,402 confirmed cases of COVID-19 in Ireland
- as of 8am today (Monday), 916 COVID-19 patients are hospitalised, of which 157 are in ICU. There have been 40 additional hospitalisations in the past 24 hours

### Numbers of people vaccinated:

As of Saturday 13 February, there have been 268,551 doses of COVID-19 vaccine administered in Ireland:

- 176,926 people have received their first dose
