The latest news as of 5.30pm on Tuesday 16 February

33 deaths and 744 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 33 additional deaths among people with COVID-19 in Ireland. 31 of these deaths occurred in February and 2 in January
- there have been 3,980 COVID-19 related deaths in Ireland
- 744 additional cases of COVID-19 have been confirmed
- there have now been 211,113 confirmed cases of COVID-19 in Ireland
- as of 8am today (Tuesday), 861 COVID-19 patients are hospitalised, of which 159 are in ICU. There have been 51 additional hospitalisations in the past 24 hours

As of Sunday 14 February, there have been 271,942 doses of COVID-19 vaccine administered in Ireland:

- 180,192 people have received their first dose
- 91,750 people have received their second dose
