The latest news as of 5.45pm on Wednesday 17 February

57 deaths and 650 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been informed of 57 additional deaths among people with COVID-19 in Ireland. 34 of these deaths occurred in February, 21 in January, 1 in December and 1 in November
- there have been 4,036 COVID-19 related deaths in Ireland
- 650 additional cases of COVID-19 have been confirmed
- there have now been 211,751 confirmed cases of COVID-19 in Ireland
- as of 8am today (Wednesday), 831 COVID-19 patients are hospitalised, of which 154 are in ICU. There have been 49 additional hospitalisations in the past 24 hours

As of Sunday 14 February, there have been 271,942 doses of COVID-19 vaccine administered in Ireland:

- 180,192 people have received their first dose
- 91,750 people have received their second dose
