**Daily status COVID-19:** number of PCR tests; persons tested positive; hospitalizations; deaths; pandemic follow-up.



1.716 Number of PCR tests performed (on residents)

6 People tested positive for Covid-19 (on residents)

40 Hospitalizations

124 Deaths
