Current situation

New Zealand has **1,283** confirmed and probable cases of COVID-19. With continued vigilance the chance of widespread community outbreak is expected to remain low.

New Zealand is currently at Alert Level 4 – Eliminate. This means that it is likely that the disease is not contained. See more information about Alert levels a.

- **Contact tracing phone calls:** If you have been identified as a close contact, you can expect calls from Ministry of Health and Healthline. It is important to answer your phone. Find out how to recognise a call from the Ministry or Healthline at <u>Contact tracing</u>.
