### **Current situation**

New Zealand has 1,312 confirmed and probable cases of COVID-19. For a summary of the current status see our <u>latest media release</u> (11 April). More information is available on our <u>current cases page</u>. With continued vigilance the chance of widespread community outbreak is expected to remain low.

### **Important updates**
