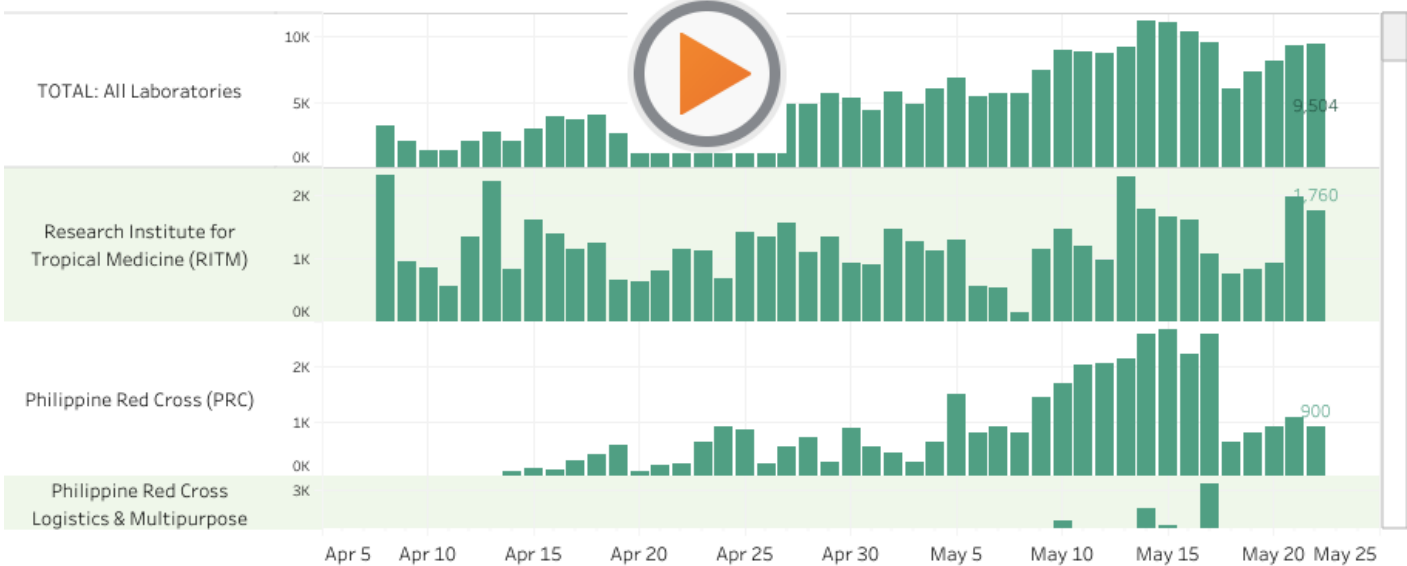

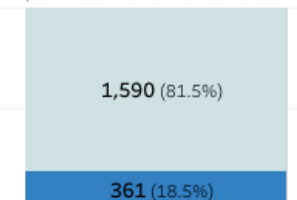
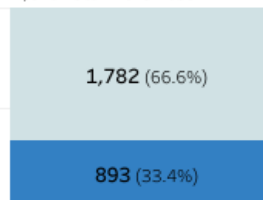
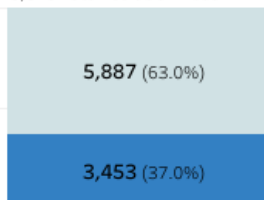
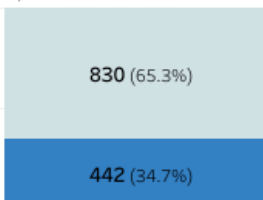

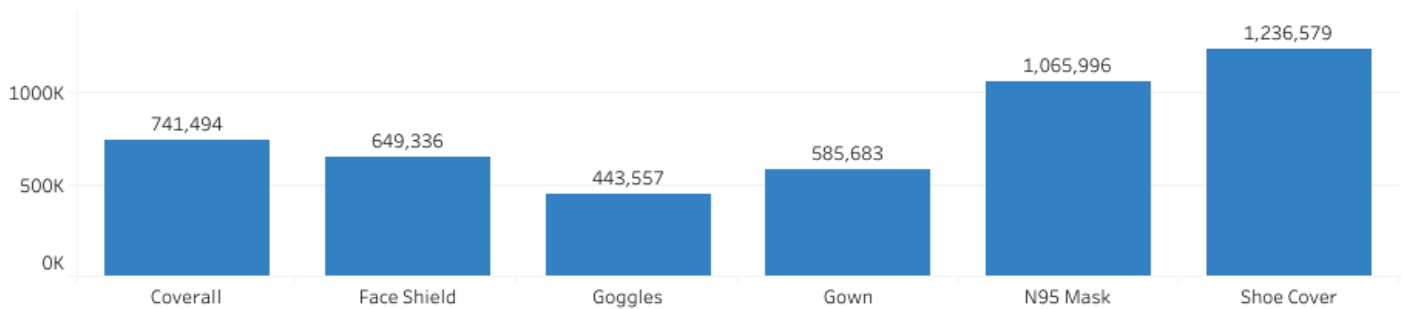

Consistent with the provisions of Republic Act (R.A.) 11469 or the “Bayanihan to Heal as One Act” and R.A. 2382 or the “Medical Act of 1959,” the Department of Health (DOH) issued the Department Memorandum No. 2020-0169 last Saturday, which allows medical graduates to engage in limited practice of medicine as deputized physicians, without need of any certificate of registration from the Professional Regulation Commission...
