## Updates on COVID-19 (Coronavirus Disease 2019) Local Situation

01 Apr 2020

### Clarifications on Misinformation

**1 April 2020:** We are aware that there are COVID-19 April Fool's pranks circulating on Whatsapp and social media. We urge public not to spread fake news and misinformation about COVID-19. Singaporeans are relying on internet and media for vital information for COVID-19, and these jokes, while benign in nature, may fan the spread of misinformation resulting in severe consequences. If you have received files from unknown or unverified source, do not click on it, or forward it further.

**27 Mar 2020:** We are aware of a message circulating on social media and text messaging platforms about a Safe-Distancing Ambassador who allegedly issued a \$300 fine to a person for sitting on a seat which was marked as 'not to be occupied'. We wish to clarify that this is false.

Safe-Distancing Ambassadors are deployed to help ensure that safe distancing measures are complied with. They do not issue fines.

**27 Mar 2020:** We are aware of scammers using automated voice calls or impersonating as MOH staff or contact tracing team, asking users to provide personal information including financial details, or



collect documents from the Ministry. We wish to clarify that:

- MOH will not ask for your financial details during contact tracing; and
- MOH will not ask you to collect documents from us, if you do not have existing matters with us.

When in doubt, please verify the authenticity of phone calls by calling MOH hotline at 1800-333-9999. It is a good practice to always verify the authenticity of instructions before offering any personal information or making payments to anyone.

### Public Health Travel Advisory (Updated 18 Mar 2020)

In view of the heightened risk of further importation of COVID-19 to Singapore, Singaporeans are advised **to defer all travel abroad** with immediate effect.

This supercedes our earlier [advisory](#) announced on 15 March to defer all non-essential travel abroad. The expansion of the travel advisory is to reduce the risk of Singaporeans being infected with the virus when abroad, and spreading it to other Singaporeans when they return.

As Singapore's measures will evolve according to the global situation, Singaporeans should check the MOH website (<https://www.moh.gov.sg/covid-19>) for the latest measures.

### Health Advisory

We urge Singaporeans to remain calm and vigilant. Singaporeans can continue to play their part by being socially responsible, practising good personal hygiene habits and complying with safe distancing measures. (click [here](#) to view other MOH Health Advisories).

Members of the public should adopt the following precautions at all times:

- Avoid close contact with people who are unwell or showing symptoms of illness;
- Observe good personal hygiene;
- Practise frequent hand washing with soap (e.g. before handling food or eating, after going to toilet, or when hands are dirtied by respiratory secretions after coughing or sneezing);
- Wear a mask if you have respiratory symptoms such as a cough or runny nose;
- Cover your mouth with a tissue paper when coughing or sneezing, and dispose the soiled tissue paper in the rubbish bin immediately; and
- Seek medical attention promptly if you are feeling unwell.

### Measures which apply to Inbound Travellers

#### Entry Approval Required For All Long-Term Pass Holders (Updated as at 28 Mar 2020)

From 29 March 2020, 2359h, all foreigners holding ICA-issued long-term passes (i.e. Long-Term Visit Pass (LTVP) or Student's Pass (STP), or In-Principle Approval (IPA) letters for LTVP/STP, who plan to enter Singapore from any country must obtain permission from the relevant agency before they commence their journey.

#### Health Declaration Via The SG Arrival Card E-Service (updated as at 23 Mar 2020)

From 27 March 2020, 0900h, all travellers arriving in Singapore, including residents [Singapore Citizens (SC), Permanent Residents (PR)], and Long-Term Pass (LTP) holders (Student's Pass, Dependant's Pass, Work Pass and Long-Term Visit Pass Holders), must submit a health declaration before proceeding with immigration clearance<sup>[1]</sup>. They will have to do so via the SG Arrival Card (SGAC) e-Service<sup>[2]</sup>. The health declaration will be made available before 27 March 2020 as part of the SGAC e-Service, so that travellers who are due to arrive in Singapore after 27 March, 0900 hours, can complete it in advance of their arrival.

<sup>[1]</sup> The Ministry of Health (MOH)'s press release dated 22 March 2020 announced that all short-term visitors (from anywhere in the world) will not be allowed to enter or transit through Singapore from 23 March 2020, 2359 hours. The Ministry of Manpower (MOM) will only allow the entry/return of Work Pass holders, including their dependents, for those providing essential services, such as in healthcare and transport.

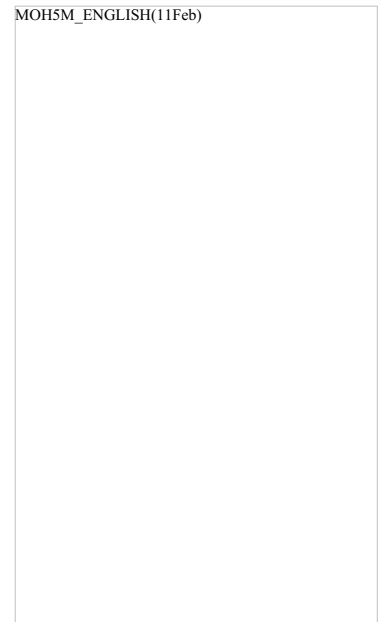

[2] The beta version of the SGAC e-Service had been rolled out on a trial basis since August 2019 to allow short-term visitors to submit information about their visit to Singapore electronically in advance of their arrival, which replaces the requirement to fill in the paper-based disembarkation/embarkation cards. As of February 2020, ICA had cleared over 560,000 electronic SGAC records submitted by short-term visitors.

#### **Border Restrictions (updated as at 22 Mar 2020)**

From 23 March 2020, 2359h, all short-term visitors (from anywhere in the world) will not be allowed to enter or transit through Singapore. MOH will therefore suspend the processing of all ASEAN Health Clearance applications until further notice.

#### **14-day Stay-Home Notice (SHN) for all Travellers (updated as at 18 Mar 2020)**

From 20 March 2020, 2359 hours, all Singaporeans, Permanent Residents, Long Term Pass holders and short term visitors entering Singapore will be issued a 14-day Stay-Home Notice (SHN)[1]. They will have to provide proof of the place where they will serve the 14-day SHN, for example a hotel booking covering the entire period, or a place of residence they or their family members own. This is to further reduce the risk of further importation leading to community spread in Singapore.

#### **COVID-19 swab test at checkpoint (updated as at 13 Mar 2020)**

From 13 Mar 2020, travellers entering Singapore and exhibiting fever and/or other symptoms of respiratory illness are required to undergo a COVID-19 swab test at the checkpoint, regardless of travel history. With immediate effect, all such travellers will also be issued a 14-day SHN, which they will have to serve in full even if the result of the swab test is negative. Those who meet the clinical suspect case definition will be conveyed to the hospital for follow-up.

Singapore Permanent Residents and long-term pass holders who refuse testing may have their immigration facilities and work pass privileges revoked or the validity shortened. All travellers, including Singapore Citizens, who do not comply with the testing or who cannot be contacted subsequently may face penalties and can be prosecuted under the Infectious Diseases Act.
