As of 25 July 2020, 12pm, the Ministry of Health (MOH) has confirmed 513 new cases of COVID-19 infection in Singapore.

Among the cases:

- Imported case: **6**
  - 2 Permanent Residents, 4 Dependant's Pass holders

Amongst the 6 imported cases, 2 are Permanent Residents who returned to Singapore from India on 12 July, and from the UK on 10 July. The remaining cases are Dependant's Pass holders who arrived from India between 11 July and 13 July. All of them had been placed on 14-day Stay-Home Notice (SHN) upon arrival in Singapore, and had been tested while serving their SHN.

- Cases in the community: **2**
  - 2 Work Permit holders

Of the 2 cases in the community, 1 was picked up as a result of our proactive surveillance and screening, and 1 had already been placed on quarantine earlier. 1 of the community cases today is linked to a previous case.

Overall, the number of new cases in the community has decreased, from an average of 9 cases per day in the week before, to an average of 7 per day in the past week. The number of unlinked cases in the community has also decreased, from an average of 5 cases per day in the week before, to an average of 4 per day in the past week.

- Cases residing in dormitories: **505**

Of the new cases, 99% are linked to known clusters, the rest are pending contact tracing.

180 more cases of COVID-19 infection have been discharged from hospitals or community isolation facilities. To date, 45,352 have fully recovered from the infection and have been discharged from hospitals or community isolation facilities.

Most of the 148 confirmed cases who are still in hospital are stable or improving. None is in the intensive care unit.

4,361 cases who have mild symptoms, or are clinically well but still test positive for COVID-19 are isolated and cared for at community facilities.

27 have passed away from complications due to COVID-19 infection.

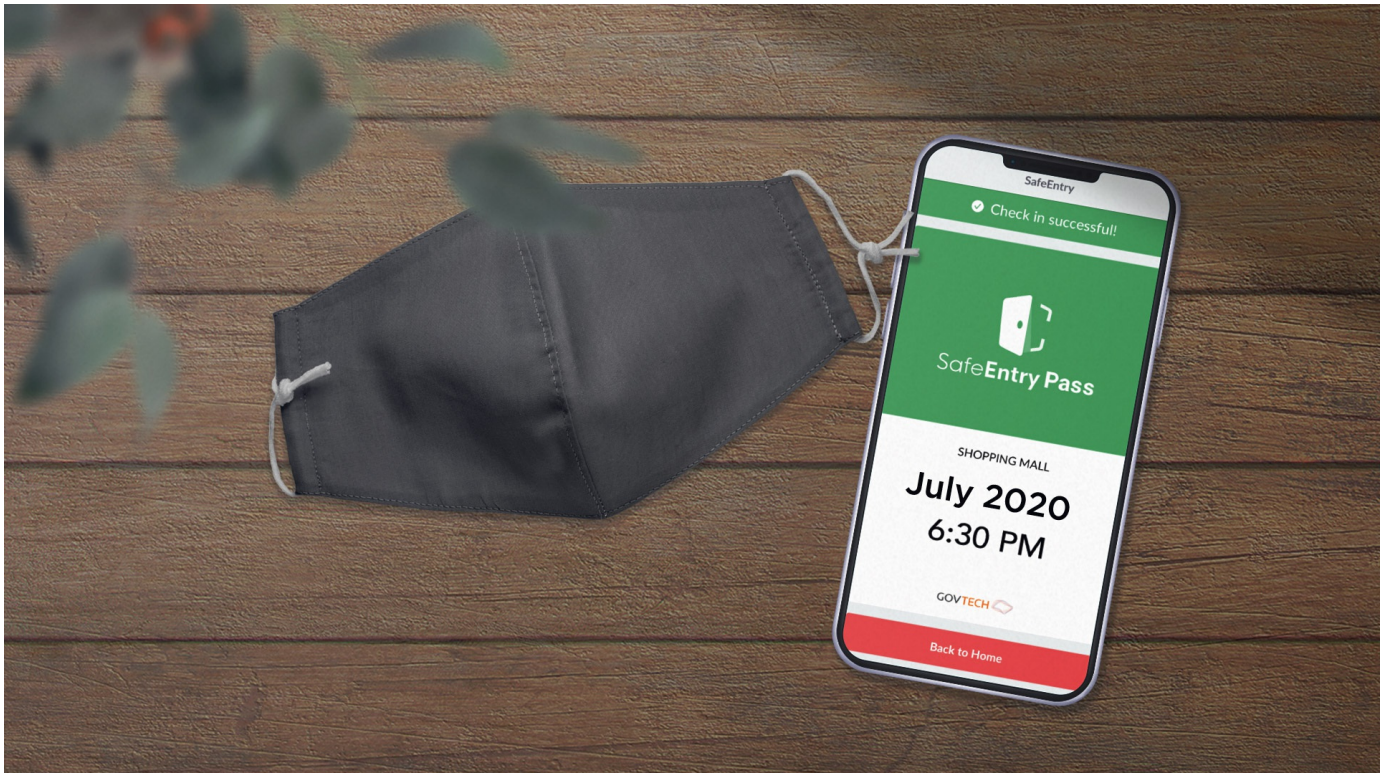
