As of 24 September 2020, 12pm, the Ministry of Health (MOH) has confirmed 15 new cases of COVID-19 infection in Singapore.

Among the cases:

- Imported cases: 5
 - o 1 Singaporean, 1 Permanent Resident, 1 Work Pass holder, 1 Dependant's Pass holder, 1 Long-Term Visit Pass holder

Amongst the 5 imported cases, 1 is a Singaporean and the other is a Singapore Permanent Resident who returned to Singapore from India on 12 September and 19 September. Another case is a Work Pass holder currently employed in Singapore who arrived from India on 12 September. The remaining cases are a Dependant's Pass holder who arrived from India on 12 September and a Long-Term Visit Pass holder who arrived from Indonesia on 22 September.

All of them had been placed on 14-day Stay-Home Notice (SHN) upon arrival in Singapore, and were tested while serving their SHN at dedicated facilities.

- Cases in the community: 0
 - There are no cases in the community today.

Overall, the number of new cases in the community has remained stable at an average of fewer than 1 case per day in the past 2 weeks. The number of unlinked cases in the community has also remained stable at an average of fewer than 1 case per day in the past 2 weeks.

• Cases residing in dormitories: 10

Amongst the 10 cases residing in dormitories, 5 had been identified earlier as contacts of previous cases, and had already been guarantined to prevent further transmission. They were tested during guarantine to determine their status.

The remaining 5 cases were detected through surveillance testing, such as the bi-weekly Rostered Routine Testing of workers living in dormitories.

Of the new cases, 73% are imported or linked to known cases/ clusters, while the rest are pending contact tracing.

42 more cases of COVID-19 infection have been discharged from hospitals or community isolation facilities. In all,57,291 have

fully recovered from the infection and have been discharged from hospitals or community care facilities.

Most of the 28 confirmed cases who are still in hospital are stable or improving. None is in the intensive care unit.

266 cases who have mild symptoms, or are clinically well but still test positive for COVID-19 are isolated and cared for at community facilities.

27 have passed away from complications due to COVID-19 infection.




