#### 3. Thailand Implementations

- The Ministry of Public Health accelerated the review of clinical laboratory standards for COVID-19 testing in Bangkok. If they confirm a positive result, they must inform the Department of Disease Control within three hours, coordinate to bring the patient into the treatment system, and report the information to the Co-Lab system for hospital bed management and timely disease control.
- The Ministry of Public Health and Food and Drug Administration (FDA) has approved additional production sites for the COVID 19 vaccine of AstraZeneca that produced by the company Siam Bioscience Co., Ltd. on April 23, 2021 by comprehensive evaluation of information, there have the quality can be proven that the quality of vaccines produce in Thailand is comparable to the quality of vaccines produced at foreign production sites.



• The Nonthaburi Provincial Administration declared an order with the following points including a temporary closure of establishments that include:

1. Closure of cow fighting, cock-fighting rings, fish-fighting rings, and entertainment venues

2. Ban on using school buildings for teaching, learning and organizing mass gathering events which include more than 10 people

3.Reopen places with preventive measures

4. Specific to disease control measures, those who are not wearing a mask, will be punished by a fine of 20,000 Baht

5. The public is asked to cooperate to refrain from leaving their residences between 21.00 - 04.00.

6. The public and private sectors are asked to cooperate in having work from home policies and staff or employees are requested to refrain from having meals together.

7. The Nonthaburi Province order no. 1019/2564 is effective from April 24, 2021 until the order is changed.

### 4. Risk Assessment of COVID-19 Situation

The global situation of COVID-19 shows more than 146 million cases have been confirmed. The daily number of new cases has increased to more than 800,000 cases per day since mid-February 2021. The growing outbreak and higher number of deaths in India is caused by the B.1.617 lineage, one of the known variants of SARS-CoV-2 that causes COVID-19. The number of worldwide deaths is still lower than 15,000 people per day and the total number of deaths is more than 3,000,000. The cumulative number of infections in the new outbreak wave in Thailand is 24,159 cases. The number of daily infections in the country has been growing. Today, there were 2,839 new cases across 68 provinces, the highest since the beginning of the outbreak. The provinces that found a high number of COVID-19 patients in this wave have been Bangkok, Chiang Mai, Chonburi, Samut Prakan, Prachuap Khiri Khan and Nonthaburi. Most of them have been infected from confirmed patients who are close contacts, such as family members and colleagues. In addition, transmission has spread to the elderly or people with chronic disease who live in the home. For the vaccination situation in Thailand, more than 1 million doses have been administered and every province should increase surveillance among patients
