3. Thailand Implementations

- The BMA had extended the closure of places until 17 May 2021. The National Health Security Office together with the Ministry of Labor had expanded service for active COVID-19 case findings for the at-risk Social Security insured persons at Wet Sports Building 1, Bangkok Youth Center (Thailand-Japan), Din Daeng, during 5 to 31 May 2021. So far, the service unit had provided COVID-19 testing to 32,453 people, of which 808 people were found to be confirmed cases (2.50%). In order to cover all target groups, it also provided the service to food delivery workers and other non-insured workers in Bangkok as well. At the same time, the BMA also agreed on the resolution to procure vaccines for other at-risk occupations such as teachers, educational personnel, public bus drivers, taxi drivers, motorcycle taxi drivers, Don Muang Airport staff, Metropolitan Electricity Authority staff, as well as street sweepers in 50 districts. The total number of these target people was estimated to be more than 500,000 people. The service would be launched as soon as additional vaccines are available.
- Yala Province had lifted the order to refrain from leaving dwellings from 10:00 p.m. to 04:00 a.m. to prevent the COVID-19 spreading. However, it still asked for public cooperation to refrain from unnecessary travel out of their houses during the time period.

4. Risk Assessment of COVID-19 Situation

According to the COVID-19 situation monitoring, the number of infected people has been continuously increasing. On 8 May 2021, there are 2,419 new cases reported. Accelerating the community immune level is therefore crucial and should be carried out as soon as possible. According to data on the COVID -19 vaccination in Thailand, it has shown that there are 1,651,782 people that have received the first dose of vaccine and 450,524 people have received the complete 2 doses. Up to the present, the Department of Disease Control (DDC) has deployed 2,402,688 doses of the vaccine to all provinces. It also requested all provinces to ask target groups to receive the vaccination as soon as possible, particularly those in high-risk areas, to reduce serious illness and death. It was emphasized that people are requested for collaboration for self-protection and reduction of the disease spreading by practicing strict preventive measures such as wearing masks, washing hands, keeping social distance and avoiding unnecessary travel to risk crowded places with poor ventilation. The people are also advised not to sit in restaurants or get together for meals, or join gathering activities that risk disease spreading. Government and business sectors are also requested to launch the 'Work From Home' measure.
