3. Thailand Implementations

- The Center for COVID-19 Situation Administration published the COVID-19 vaccine management guidelines allowing 5 agencies, namely the Department of Disease Control (DDC), the Government Pharmaceutical Organization (GPO), the National Vaccine Institute (NVI), the Thai Red Cross Society, and the Chulabhorn Royal Academy to procure, order or import the vaccines as of urgent need in order to provide people with quality and effective vaccines quickly and thoroughly.
- The Office of the National Security Council Construction will initiate labor control measures in the construction camps so that the number of infected people will not increase. The Bangkok Metropolitan Administration and the Ministry of Public Health have requested security forces from both police and military to help control the areas to prevent the movement of workers. Now, migrant workers at several establishments and construction sites are still moving. In addition, more proactively detecting infections is ready to be moved forward.
- The Chulabhorn Royal Academy has disclosed the process of booking Sino Farm vaccine in phase 1 for organizations and agencies by allowing them to register for receiving the allocation of the Sino Farm vaccine via the online system at https://vaccine.cra.ac.th from 14 June 2021 at 8:00 a.m. onwards. In addition, they need to prepare the legal documents for submitting an application for allocation of alternative vaccines via the online system. The vaccinated people will also be able to check information on vaccination via "Mor Prom" of the Ministry of Public Health.

4. Risk Assessment of COVID-19 Situation

According to the COVID-19 situation monitoring on 10 June 2021, in Thailand, there were 187,538 accumulated infected cases. There are 2,310 new cases today of which 1,467 cases are from local transmission and 43 new deaths were reported. The total new daily cases have continuously been over 2000 and there have been reports of outbreaks in many areas, especially in Bangkok and its vicinity. In some provinces in the central and eastern regions, the outbreaks were reported in the establishments, factories, and markets that are crowded while infection in other provinces occurred among the family members, relatives by having close contact with each other through various community activities. According to the COVID-19 vaccination database, more than 4 million doses of the vaccine have been injected. During this period, all provinces should continue to conduct proactive screening in high-risk areas such as prisons, markets, establishments and densely populated communities. The provinces in upcountry should carefully observe the sick symptoms of people traveling from Bangkok, its vicinity and all areas where the outbreak is found. The vaccination services should include the elderly, chronic disease patients and obese people. It is essential to communicate with the public to maintain personal disease prevention measures such as wearing a hygienic mask or cloth mask when going outside of their houses, working from home as much as possible, reducing unnecessary traveling, especially to high-risk crowded places, avoiding group talking or eating together and getting vaccinated according to their own rights.
