3. Thailand Implementations

- The Cabinet, Prime Minister and Minister of Defense organized a meeting to discuss the management of COVID-19 patients for home treatment or 'Home Isolation' including community isolation treatment, the transfer of patients from Bangkok health facilities back to their homes, as well as a proposal to review easing measures for four types of businesses that are essential to people's lives to be reopened in shopping centers, including banks, financial institutions, IT communication businesses, miscellaneous shops and electronics shops.
- The Social Security Office provided advice for employees who receive benefits and compensation for lack of income. Employees infected with SARS-CoV-2 must self-isolate at home and are able to receive 50% compensation of their wages. If their physician determines that the employee is under the criteria for inpatient care while awaiting hospitalization, an employee can also receive the amount covering medical fees under the inpatient payment criteria.
- Thailand's Centre for COVID-19 Situation Administration (CCSA) will evaluate the spread of the COVID-19 situation on 16 August 2021 to consider whether the lockdown will continue intensively for another two months or if they may relieve some activities, and speed up vaccination administration services according to the target groups.

4. Risk Assessment of COVID-19 Situation

The global COVID-19 situation shows that there are more than 206 million cases with the number of daily cases beginning to increase again after June to more than 600,000 people per day. There are still many outbreaks in places like the USA, India and Brazil. The daily number of deaths is also likely to increase to more than ten thousand a day with the total number of deaths exceeding 4.3 million. The situation in Thailand showed that the cumulative number of COVID-19 infections has been confirmed at 856,412 cases. Today, there were 21,813 new cases confirmed from the 77 provinces and 270 new infections from prisons. The daily number of infected people is likely to increase to more than 20.000 per day. The epidemic has spread in all regions of the country and found a large number of new infections in the central region, Northeast and the lower South. The total number of fatal cases in this wave has reached 7,249 people, with a mortality rate of 0.85%. Almost all of the deaths were elderly and people with chronic disease. Almost all of them were not vaccinated. For the current vaccination situation in Thailand, more than 23.1 million doses have been administered and high numbers of infected cases are expected to continue for at least 1-2 weeks. Therefore, all people, healthcare workers, and staff (both vaccinated and unvaccinated) must strictly comply with the D-M-H-T-T-A self-protection measures to reduce transmission. These preventive measures include keeping a distance of at least 1-2 meters, limiting the number of people in each area, applying working from home policies, wearing a hygienic mask or cloth mask at all times, washing hands every time after touching surfaces that may be contaminated such as elevators, doorknobs, handrails, etc., checking body



temperature when traveling to public places, and screening for COVID-19 when suspected symptoms develop.
