# Coronavirus (COVID-19): daily data for Scotland

This is updated each day to provide the latest available data on COVID-19 in Scotland.

### Scottish numbers: 1 June 2020

- 18 new confirmed cases of COVID-19
- 1 new reported death of people who have tested positive

A total of 115,259 people in Scotland have been tested through NHS labs to date. Of these:

- 99,841 were confirmed negative
- 15,418 were positive

This will be an underestimate of the number of cases. Not everyone with the virus will display symptoms and not all those with symptoms will be tested.

Of the people who have tested positive:

- 3,695 inpatients have been discharged from hospital since 5 March
- 735 were in hospital last night: 20 of whom were in intensive care, with another 7 with suspected COVID-19 in intensive care
- 2,363 have died

Numbers in hospital were previously reported in this table as the total of confirmed and suspected. However from 5 May 2020 onwards these are confirmed only. This is due to discontinuity in suspected cases due to increased levels of screening.

#### **Testing**

On 31 May there were:

- 2,096 tests carried out by NHS Scotland in hospitals, care homes or the community, making a total of 171,745 COVID-19 tests through NHS labs to date.
- in addition, there were 633 drive through and mobile tests carried out by the Regional Testing Centres in Scotland bringing the total to 59,649 tests to date.

As of 25 May, there were:

• At least 36,208 key workers or symptomatic family members had been tested through NHS laboratories. Of those tested approximately 55% were healthcare workers or their families, 36% were social care staff and family members and 7% were from the rest of the public sector, including the prison service and firefighters.

# Community health and care

On 31 May there were:

- 6,531 calls to 111 and 194 calls to the Coronavirus Helpline. The number of calls to 111 includes all calls, whether or not they relate to COVID-19.
- 1,629 Scottish Ambulance Service (SAS) attendances, of which 217 were for suspected COVID-19. SAS took
   150 people to hospital with suspected COVID-19.

As at 29 May there were:

738 people delayed in hospital. This is 874 less than the baseline period (04/03 weekly return).

#### **Care homes**

On 31 May there were:

- 481 (44%) adult care homes with a current case of suspected COVID-19. At least one resident in the care home has
  exhibited symptoms during the last 14 days.
- 668 (62%) adult care homes which have lodged at least one notification for suspected COVID-19 to the Care Inspectorate since the start of the epidemic. 500 of these care homes have reported more than one case of suspected COVID-19.
- 5,962 cumulative cases of suspected COVID-19 in care homes. This is an increase of 4 suspected cases on the previous day.

#### Health and social care staff

- 5,739 NHS staff, or around 3.5% of the NHS workforce, reported as absent on 31 May due to a range of reasons related to COVID-19.
- 3,049 staff were reported as absent in adult care homes due to COVID-19, based on returns received from 880 (81%) adult care homes as at 26 May. Staff absent due to COVID-19 represents 6.6% of all adult care home staff (46,237) for whom a return was provided.

The absence figures for NHS staff and care home staff are calculated in different ways and caution should be exercised in making comparisons – see the data sources and definitions document for full details.

#### Deaths of health and social care workers related to COVID-19

As at 26 May, we have been notified by Health Boards or the Care Inspectorate of 7 deaths of healthcare workers and 11 deaths of social care workers, related to COVID-19. We are not able to confirm how many of these staff contracted COVID-19 through their work. We update this information every Wednesday.

#### About this data and other data sources

The data reported is management information based on a range of operational systems. While checks are completed before publication to ensure data robustness, due to the speed of reporting these data are not currently subject to the full range of processes and quality assurance that would be required for Official Statistics. ## COVID-19: modelling the epidemic in Scotland

The Scottish Government, like other governments around the world, is responding to the COVID-19 pandemic. A key part of this response is to model the potential spread and level of the virus in Scotland, and to compare the Scottish experience to other parts of the UK and other countries around the world. The results of this work are used to help the Scottish Government and the wider public sector, and in particular the health service, plan and put in place what is needed to keep us safe and treat people who have virus e.g. to decide how many Intensive Care Beds (ICU) we need for Covid patients. A weekly report on COVID-19 related deaths (including those where COVID-19 is suspected) is available from National Records of Scotland (NRS). This report provides a breakdown of deaths by age, sex, setting (hospital, care home or home) and area (NHS Board area and Local Authority). It is updated every Wednesday.
