# Coronavirus (COVID-19): daily data for Scotland

This is updated each day to provide the latest available data on COVID-19 in Scotland.

## Scottish numbers: 9 July 2020

- 6 new confirmed cases of COVID-19
- 0 new reported death(s) of people who have tested positive

A total of 289,646 people in Scotland have been tested through NHS Scotland labs and UK Government Labs to date. Of these:

- 271,331 were confirmed negative
- 18,315 were positive

This will be an underestimate of the number of cases. Not everyone with the virus will display symptoms and not all those with symptoms will be tested.

Of the people who have tested positive:

- 4,116 inpatients have been discharged from hospital since 5 March
- 342 were in hospital last night: 3 of whom were in intensive care; plus 6 more people in intensive care with suspected COVID-19
- 2,490 have died

This table now includes confirmed cases where people have been tested through the UK Government (UKG) testing programme as well as those through NHS Scotland labs. Case numbers are by board of residence (if postcode is not known, location of test is used); numbers of inpatients are by location of the hospital.

## Testing

On 8 July there were:

- 4,057 tests reported on that were carried out by NHS Scotland in hospitals, care homes or the community, making a total of 303,610 COVID-19 test results from NHS Labs to date.
- 6,551 tests reported on that were carried out at Mobile Test Units, Drive Throughs, by the Care Home Portal and through Home Tests, making a total of 171,454 COVID-19 test results from UKG Labs to date.

As of 6 July:

- At least 58,957 key workers or symptomatic family members had been tested through NHS laboratories. Of those tested approximately 40% were healthcare workers or their families, 50% were social care staff and family members and 5% were from the rest of the public sector, including the prison service and firefighters.

## Care homes

On 8 July there were:

- 113 (10%) adult care homes with a current case of suspected COVID-19. From 29 June the Care Inspectorate has revised the definition of care homes with current suspected case to exclude any home that has not notified of a new case of suspected COVID for at least 28 days. - 692 (64%) adult care homes which have lodged at least one notification for suspected COVID-19 to the Care Inspectorate since the start of the epidemic. 540 of these care homes have reported more than one case of suspected COVID-19.
- 6,697 cumulative cases of suspected COVID-19 in care homes. This is an increase of 15 suspected cases on the previous day.

Over the week commencing 29 June:

- At least 2,678 individual care home staff, and 302 residents were tested in care homes with a confirmed case of COVID-19.
- At least 30,673 individual care home staff, and 2,002 residents were tested in care homes with no confirmed cases of COVID-19.

## Community health and care

On 8 July there were:

- 2,432 calls to 111 and 389 calls to the Coronavirus Helpline. The number of calls to 111 includes all calls, whether or not they relate to COVID-19.

On 3 July there were:

- 1,629 Scottish Ambulance Service (SAS) attendances, of which 243 were for suspected COVID-19. SAS took 180 people to hospital with suspected COVID-19.

On 8 July there were:

- 841 people delayed in hospital. This is 771 fewer than the baseline period (04/03 weekly return).

As at 6 July:

- 181,225 people in Scotland are identified as at high clinical risk of COVID-19 and are advised to shield.
- Almost three quarters (131,987 people) are aged 55 or over and 2% (3,867) are children under the age of 16. Demographic breakdowns of those on the shielding list at 1 June were published in the PHS Coronavirus (COVID-19) weekly report for Scotland on 10 June.
- Local authorities have had direct contact with 96% of those advised to shield (either through proactive contact or receipt of calls) to discuss support needs.
- A total of 97,874 people are registered with the shielding SMS service.
- There were 48,767 individuals signed up for weekly food box deliveries and 46,020 registered for priority supermarket delivery. Individuals can sign up for these services either via SMS registration or by contacting their local authority.

## Health and social care staff

- 3,828 NHS staff, or around 2.3% of the NHS workforce, reported as absent on 8 July due to a range of reasons related to COVID-19.
- 1,764 staff were reported as absent in adult care homes due to COVID-19, based on returns received from 807 (75%) adult care homes as at 07 July. Staff absent due to COVID-19 represents 4.2% of all adult care home staff (41,680) for whom a return was provided.

The absence figures for NHS staff and care home staff are calculated in different ways and caution should be exercised in making comparisons – see the data sources and definitions document for full details.

## Deaths of health and social care workers related to COVID-19

As at 7 July, we have been notified by Health Boards or the Care Inspectorate of 7 deaths of healthcare workers and 13 deaths of social care workers, related to COVID-19. We are not able to confirm how many of these staff contracted COVID-19 through their work. We update this information every Wednesday.

## COVID-19: modelling the epidemic in Scotland

The Scottish Government, like other governments around the world, is responding to the COVID-19 pandemic. A key part of this response is to model the potential spread and level of the virus in Scotland, and to compare the Scottish experience to other parts of the UK and other countries around the world. The results of this work are used to help the Scottish Government and the wider public sector, and in particular the health service, plan and put in place what is needed to keep us safe and treat people who have virus e.g. to decide how many Intensive Care Beds (ICU) we need for Covid patients. This report provides a breakdown of deaths by age, sex, setting (hospital, care home or home) and area (NHS Board area and Local Authority). It is updated every Wednesday.
