Coronavirus (COVID-19): daily data for Scotland

This is updated each day to provide the latest available data on COVID-19 in Scotland.

Scottish numbers: 10 August 2020

- 29 new confirmed cases of COVID-19; this is 0.8% of newly tested individuals.
- 0 new reported death(s) of people who have tested positive (noting that Register Offices are now generally closed at weekends).
- 3 people were in intensive care last night with confirmed COVID-19.
- 267 people were in hospital with confirmed COVID-19.
- 10,319 new tests for COVID-19 that reported results.

Figures by health board area

- COVID-19 positive cases and patients in hospital at both Scotland level and Health Board level are provided in published excel files - <u>Trends in daily data</u>.
- further information is provided in the <u>Public Health Scotland dashboard</u> 2. This now provides trend information for Health Board areas and Local Authorities.

Weekly figures

- Positive tests: week ending 10 August: 29,680 people tested 333 positive
- Number of tests: 84,081 tests reported week ending 10 August.
- Care homes: as at 5 August: 60 (6%) adult care homes with a current case of suspected COVID-19.
- Care homes confirmed cases: 0 new positive COVID-19 cases among care home residents for week 24 31 July. Please see the <u>Definitions and Sources</u> page for details on this new measure.
- Care homes testing: week ending 30 July: At least 1,004 individual care home staff, and 150 residents were tested in care homes with a confirmed case of COVID-19. At least 35,153 individual care home staff, and 1,649 residents were tested in care homes with no confirmed cases of COVID-19. <u>Health Board data is available</u>.
- Hospital admissions: week ending 29 July : 5 COVID-19 patients were admitted to hospital.
- Deaths: week ending 2 August: 7 COVID-19 deaths were registered, of which 2 were in care homes and 4 in hospital.
- Delayed discharges: As at 05 August: 921 people were delayed in hospital.
- NHS staff absence: week ending 4 August: On average, 2,913 NHS staff, or around 1.7% of the NHS workforce, reported absent each day for a range of reasons related to COVID-19.
- Care homes staff absence: week ending 4 August: 815 staff were reported as absent in adult care homes due to COVID-19, based on returns received from 799 (74%) adult care homes. Staff absent due to COVID-19 represents 2.0% of all adult care home staff (41,702) for whom a return was provided. The absence figures for NHS staff and care home staff are calculated in different ways and caution should be exercised in making comparisons.
- Shielding: As at 3 August, 180,228 people who were identified as at high clinical risk of COVID-19 had been advised to shield up to the end of July. There have been 5,426 deaths (from all causes) of those
