# Coronavirus (COVID-19): daily data for Scotland

This is updated each day to provide the latest available data on COVID-19 in Scotland.



## Scottish numbers: 2 September 2020

- 156 new confirmed cases of COVID-19; this is 1.0% of newly tested individuals.
- 1 new reported death(s) of people who have tested positive.
- 5 people were in intensive care last night with confirmed COVID-19.
- 258 people were in hospital with confirmed COVID-19.
- 27,246 new tests for COVID-19 that reported results.

## Weekly figures

- positive tests: week ending 2 September: 99,171 people newly tested – 800 positive
- number of tests: 163,169 tests reported week ending 2 September.
- care homes: as at 26 August: 66 (6%) adult care homes with a current case of suspected COVID-19
- care homes confirmed cases: 1 new positive COVID-19 cases among care home residents for week 17 - 23 August. Please see the [Definitions and Sources](#) page for details on this new measure
- care homes testing: week ending 27 August: At least 460 individual care home staff, and 37 residents were tested in care homes with a confirmed case of COVID-19. At least 36,550 individual care home staff, and 1,363 residents were tested in care homes with no confirmed cases of COVID-19. [Health Board data is available](#)
- hospital admissions: week ending 26 August: 19 COVID-19 patients were admitted to hospital.
- deaths: week ending 30 August: 6 deaths were registered where COVID-19 was on the death certificate
- delayed discharges: As at 26 August: 1,011 people were delayed in hospital
- NHS staff absence: week ending 1 September: On average, 1,785 NHS staff, or around 1.0% of the NHS workforce, reported absent each day for a range of reasons related to COVID-19.
- care homes staff absence: week ending 25 August: 554 staff were reported as absent in adult care homes due to COVID-19, based on returns received from 775 (72%) adult care homes. Staff absent due to COVID-19 represents 1.4% of all adult care home staff (40,323) for whom a return was provided. The absence figures for NHS staff and care home staff are calculated in different ways and caution should be exercised in making comparisons.
- shielding: as at 3 August, 180,228 people who were identified as at high clinical risk of COVID-19 had been advised to shield up to the end of July. At that time, there had been 5,426 deaths (from all causes) of those who had been advised to shield. Shielding has been paused since the beginning of August
