## COVID-19 Vaccine Doses Shipped

January 17, 2021

This includes doses shipped to Local Health Jurisdictions (the 58 county public health department and 3 city public health departments) and large health systems or state departments that span multiple counties (multi-county entities)

**As of January 16, providers have reported administering a total of 1,303,518 vaccine doses statewide. Numbers do not represent true day-to-day change as reporting may be delayed. As of January 16, a total of 3,226,775 vaccine doses, which includes the first and second dose, have been shipped to local health departments and health care systems that have facilities in multiple counties.**

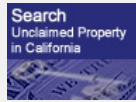
