Weekly COVID-19 Public Health Report - November 19, 2020

The Weekly Public Health Report includes enhanced, more granular information to be updated on a weekly, or biweekly basis.

- Individuals released from isolation (recovered)
- Cases and case rate by age for last two weeks
- Probable cases
