Weekly COVID-19 Public Health Report - November 27, 2020

The Weekly Public Health Report includes enhanced, more granular information to be updated on a weekly, or biweekly basis.

- Contact tracing cases and outreach
- Individuals released from isolation (recovered)
- Cases and case rate by age for last two weeks
- Probable cases
- Cases and deaths in Long Term Care Facilities
- Infection control survey results at nursing homes
- PPE Distribution

County Level Positivity Rates - November 25, 2020

This chart summarizes count and rate of confirmed COVID-19 cases and tests performed in MA by county over the past 14 days. Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.

- Total residents and staff as well as COVID-19 positive residents and staff
  at congregate care sites under the Department of Developmental Services,
  Department of Children and Families, Department of Mental Health,
  Department of Public Health, Department of Youth Services, the Massachusetts
  Commission for the Blind, and the Massachusetts Rehabilitation Commission.
- EOHHS mobile testing program data
- Department of Corrections onsite testing data
