Some information previously shown in the weekly dashboard is also included: age groups, race and ethnicity, and sex of cases, hospitalizations and deaths; and city/town specific metrics.

The EOHHS COVID-19 Reporting includes data on Executive Office of Health and


Human Services (EOHHS) state-operated facilities and congregate care sites.
