## COVID-19 Interactive Data Dashboard

PLEASE NOTE: Today's dashboard includes an update to the total case numbers. DPH received corrected laboratory reports on approximately 1,500 cases that a lab had reported as positive. Retesting resulted in 863 of those cases being removed from the case counts.

The COVID-19 Daily Dashboard is now available in a more interactive format. Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.

- Total residents and staff as well as COVID-19 positive residents and staff at congregate care sites under the Department of Developmental Services, Department of Children and Families, Department of Mental Health, Department of Public Health, Department of Youth Services, the Massachusetts Commission for the Blind, and the Massachusetts Rehabilitation Commission.
