COVID-19 Interactive Data Dashboard

NOTE: Due to technical issues being experienced by the Tableau hosting platform on all of their public sites, today's COVID-19 interactive dashboard is only intermittently available. We are working with Tableau to restore full access as soon as possible.

Updated daily by 5 p.m.

The COVID-19 Daily Dashboard is now available in a more interactive format. All of the same data previously provided is still available, including: data on confirmed and probable cases, testing, hospitalizations, hospital capacity and deaths. Some information previously shown in the weekly dashboard is also included: age groups, race and ethnicity, and sex of cases, hospitalizations and deaths; and city/town specific metrics.

Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.
