#### COVID-19 Interactive Data Dashboard

Updated daily by 5 p.m.

If you are having difficulty viewing the dashboard on a mobile or tablet device, you can Link to the Mobile View of the COVID-19 Dashboard.

The COVID-19 Daily Dashboard is now available in a more interactive format. All of the same data previously provided is still available, including: data on confirmed and probable cases, testing, hospitalizations, hospital capacity and deaths. Some information previously shown in the weekly dashboard is also included: age groups, race and ethnicity, and sex of cases, hospitalizations and deaths; and city/town specific metrics.

Weekly COVID-19 Public Health Report - March 18, 2021

The Weekly Public Health Report includes enhanced, more granular information to be updated on a weekly basis.

- Contact tracing cases and outreach
- Individuals released from isolation (recovered)
- Cases and deaths in Long Term Care Facilities
- Infection control survey results at nursing homes
- PPE Distribution

County Level Positivity Rates - March 17, 2021

This chart summarizes the counts and rates of confirmed COVID-19 cases and tests performed in MA by county over the past 14 days. Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.

  Commission for the Blind, and the Massachusetts Rehabilitation Commission.

- Department of Corrections onsite testing data
