All of the same data previously provided is still available, including: data on confirmed and probable cases, testing, hospitalizations, hospital capacity and deaths. Some information previously shown in the weekly dashboard is also included: age groups, race and ethnicity, and sex of cases, hospitalizations and deaths; and city/town specific metrics.

Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.

- Total residents and staff as well as COVID-19 positive residents and staff at congregate care sites under the Department of Developmental Services, Department of Children and Families, Department of Mental Health, Department of Public Health, Department of Youth Services, the Massachusetts Commission for the Blind, and the Massachusetts Rehabilitation Commission.
